- Speer Financial presentation of bids received for the sale of approximately \$155,100 Taxable General Obligation Limited Tax Park Bonds, Series 2023A and \$506,400 General Obligation Limited Tax Park Bonds, Series 2023B -

Aaron Gold of Speer Financial reviewed the bids received. He reported three bids were received for each issue. He indicated the low bid received for the Series 2023A bond issue was Peoples National Bank of Kewanee, Kewanee, IL with an interest rate of 5.18% and Series 2023B bond issue was Busey Bank, Peoria, Illinois, with an interest rate of 5.08%. He recommended awarding the low bid received. Aaron Gold indicated the bonds generate an additional \$100,000 of new capital and will close November 2, 2023.
