President Ranney called the meeting to order at 6:00 p.m. and all stood to recite the Pledge of Allegiance.

#### 8. Fair Board Representative Report:

Cameron Bettin reported they met Tuesday, September 19<sup>th</sup>. The focus of the meeting was on the Fair. All went very well and Fair Board members were very complimentary of the concessions and how clean the area was. The Fair Board has approximately \$6,700 left for the year and will help with small projects such as installation of an HVAC system in the hallway between Parkside Fitness and the Memorial Arena. He also reported that Joy Schwarting went off the Board and they will have a new member.

#### 9. Pekin Park Foundation Report:

Commissioner Gary Gillis reported the following:

August's meeting information was included in your board packet.

The Foundation approved payment of the bills associated with Larry's Casting Kids totaling \$1500 paid from the established account that was previously funded. This memorial fund for Larry Goodlick now has a low balance. The board agreed to investigate sponsorship- perhaps Bass Pro Shop- or consider Foundation sponsorship,

Bicentennial Committee- ED will update in his report. The Foundation agreed to move forward toward sponsoring the events for the park July 6, 2024- depending on final proposal.

Sunken Garden Fountain- ED reviewed past cost estimate of \$922,808 including a 20% contingency of \$154,000. Discussion ensued and it was decided to consider a Capital Campaign next year after we conduct a Pekin Park Foundation Introductory mass mailing this Fall.

Direct Mail Campaign- it was agreed to purchase a mailing list containing 814 households meeting certain prospect criterion. We will purchase list from McDaniels Marketing; get bids on printing the letters and envelopes; and have PCHS Life Skills do the labeling and placement of stamps.

# 10. Executive Director's Report: (ED) -

The Ed reported the following:

 He and Scott Clausen attended a meeting regarding the Performance Arts Venue. The Farnsworth work is done. The estimated cost to build the shelter is 1.2 million. The shelter is of pre-fab construction and will require site work and a concrete base. Engineer's drawings need to be completed. He is going to put the topic on the October 5<sup>th</sup> board meeting agenda. The Performance Arts Venue fundraising group would like to move forward with construction of the concrete base, while they continue to raise funds for completion of the project. He indicated he came out against that concept at a recent meeting and his opinion was not well received. The ED would like to see all the funds needed come in and then do the project in its entirety.

#### 11. Attorney's Report:

Mike Seghetti reported he was continuing work on the sale of a parcel of park district property to IAWC.

#### 12. Staff Reports:

Alisha Dault passed out information for the Miller Center's 16<sup>th</sup> Annual Walk for a Ride fundraising event for the Center's transportation program.

Cory Proehl reported just under \$12,000 has been received from gaming machines at Parkview and Lick Creek Golf Courses.

Shawn Powers asked Commissioners who would like to participate in the Winter Wonderland Festival parade.

#### 13. Commissioner Comments:

Kyle Cain thanked Shawn Powers for use of the dragon boat for the Marigold Festival.

Greg Ranney mentioned Gary Gillis recited the entire Gettysburg Address at a recent Rotary Club dinner and Alisha Dault was the winner of the 50/50 drawing.

#### 15. New Business:

 Discussion of the Park District festivities planned for the City of Pekin Bicentennial Celebration July 5 & 6, 2024 –

The ED indicated the park district was asked to come up with activities for the City's bicentennial celebration July 4-7. He noted that decisions still need to be made regarding July  $4^{th}$  fireworks celebration due to construction work in the stadium. He noted that

the Pekin Concert Bard will perform Sunday, July 7th. He stated he attended a recent meeting and reported the park district's preliminary plans. He reported the park's plans are to have a fun day for residents on Saturday, July 6th from 3:00 to 9:00 p.m. He mentioned the following: Fun on the Run and other activities for children, a Pavilion Porch Party (5:00 to 9:00 pm) with a band and alcohol served from 5:30 to 8:30 p.m., balloon rides on ball diamond #1 and fireworks to end the evening around 9:00 p.m. He noted they investigated drone shows and laser light show, but both are between \$9,000 and \$40,000. They have also discussed \$2.00 discount to DragonLand, Miniature Golf and Boats on the 5th. He again noted that the volunteer Bicentennial group still needs to decide what to due for the July 4<sup>th</sup> celebration. He noted they have discussed moving to the Avanti's Dome and Pekin Sports Complex. The ED indicated he does not feel the PSC is a good option and that the community will be upset if the holiday celebration is held any day other than the 4<sup>th</sup>. He also noted that the committee asked about the possibility of the park district hosting a "Free" day in the park. He also reported that the Park Foundation is providing \$14,000 sponsoring the Park District's activities.
